A. CALL TO ORDER

Chair Negrete called the Regular Meeting of the Board of Directors to order at 4:02 P.M. Directors Frank McElwain, Monique Fabela, Wes Baker, Noel Negrete and Jean Yanich were present. She suggested the district look into getting a quote to see if solar could be a good money saving option for our power needs. After some discussion Director Baker motioned to forgive the undercharged amount on account 32500, to offer credit on account 01237, and proceed with billing correct charges going forth. The motion was seconded by Director Yanich and passed with 5 ayes, 0 nays.
